

## **TERMS AND CONDITIONS**

### **Website Terms and Conditions of Use Relating to Tee2Pin.co.za**

These Terms and Conditions (“the Terms and Conditions”) govern your (“the User”) use of the **Tee2Pin GC** (“Provider”) website located at the domain name **Tee2Pin.co.za** (“the Website”). By accessing and using the Website, the User agrees to be bound by the Terms and Conditions set out in this legal notice. The User may not access, display, use, download, and/or otherwise copy or distribute Content obtained on the website for marketing and other purposes without the consent of the Provider.

### **Electronic Communications**

The Provider undertakes that it has taken all reasonable precautions to secure the credit card processing that is carried out to receive payment for goods sold. The Provider cannot be held responsible for security breaches occurring on the User’s electronic device (Personal Computer or other electronic device used to browse the Website), which may result due to the lack of adequate virus protection software or spyware that the User may inadvertently have installed on his/her device.
